Supplementary Regulations

[1] Announcement

The Pre-War Austin 7 Club Ltd. will organise a Clubmans Permit Car Trial on Wednesday, 29th December 2021 at The Lockwell Hill Activity Centre, Kirklington Road, Farnsfield, Newark, NG22 8JG.

[2] Jurisdiction

This meeting will be held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.

[3] Permits

MSUK Permit No: 123079

[4] Eligibility

The event is open to all fully-elected members of the organising club and the following Clubs: - VSCC and 750 MC.

All Drivers and Passenger MUST produce a valid RS Clubman Licence and Club Membership Card (T.3.1.5)

[5] Championships

The event is a round of; NO Championship

[6] Scrutineering/Programme

Signing on and Scrutineering from 08:30. All vehicles must comply with the Motorsport UK Technical Regulation 2021.

[7] Event Start

The event will start at 10:00

Drivers Briefing at 09:45

Any competitor not signed on by 09:45 may be excluded.

If all competitors are present, then the start time will be brought forward.

[8] Description of Event

Public roads will not be used to link sections.

There will be a minimum of 5 sections, to be attempted at least 3 times, details of these sections will be issued at signing on. The entry will be split into groups starting at different sections.

[9] Vehicles Starting Positions

Competitors starting section will be notified at signing on.

[10] Practicing Requirements

Practicing will NOT be permitted.

[11] Identification

Identification number will be supplied by the organisers. Starting numbers will be allocated by the organisers.

[12] Awards

Awards will be presented as follows: -

There will be awards for the Overall winner and for the best in each class subject to at least three starters in the class

[13] Entries

The maximum entry for the meeting is 40 and the minimum is 15. Should any of the above figures not be reached, the organisers have the right to amalgamate classes or cancel the event. Entries will be selected in order of receipt.

Marking and penalties will be as printed in section T.6 Motorsport UK Regs 2021.

An engine stall is considered an immediate stop and no time allowance will be made for restarting, with the exception of a stall on a downhill section where the car keeps moving and the competitor is able to restart the engine, then there is no penalty.

The current Tyre List for trials will be deemed to take precedence.

Tyre pressures will be advised at the start and may be checked during the event with the clubs pressure gauge. The CoC reserves the right to amend tyre pressures by up to 5psi during the trial.

A brake and differential test may be performed on each competing car before the start of the event.

Any driver allowing an unauthorised person (i.e. one who has not signed on the official indemnity form for the event) to drive their car will be disqualified from the event immediately.
